Overview

Michael Cassel Group's (MCG) Work Experience Program 2024 will create opportunities for secondary school, tertiary and vocational education students, recent graduates and early-career creatives to learn from MCG's expertise as producers and presenters of world-class theatrical productions and live entertainment.

The program will offer work experience opportunities to engage with MCG and gain an understanding of the inner workings of a live entertainment company. Successful applicants will go behind-the-scenes of professional theatrical productions and may have access to mentorships, exclusive events, complimentary tickets, networking opportunities and more.

The program comprises of three options as follows;

- **Professional placements** in partnership with tertiary institutions, vocational education providers and accredited academic programs.
- **Internships** with MCG's Marketing and Production teams, based in MCG's Sydney or Melbourne offices.
- **Work experience** on MCG's live productions.

About the Program

The MCG Work Experience Program gives successful applicants the opportunity to gain experience working in the live entertainment industry. As part of the program, successful applicants will spend time onsite at MCG's offices or productions, engaging with various MCG team members and departments, whilst embarking on learning development tasks.

In 2024, MCG will offer work experience across the following productions:

- & JULIET (Sydney Season)
- HAMILTON (Sydney Season)
- MJ THE MUSICAL (Sydney, Pre-Production)
- BEETLEJUICE THE MUSICAL (Melbourne, Pre-Production)

In addition, MCG will offer professional placements and internships at MCG's Sydney and Melbourne offices. Additional projects, events and opportunities may arise throughout the year.

Michael Cassel Group is committed to inclusivity and accessibility. We encourage applicants from all backgrounds and educational institutions to apply, including First Nations, CALD, LGBTQI+ communities and people with disabilities.

Eligibility for Program Options

1. Professional Placement

For students enrolled in tertiary or vocational education courses

Professional placement is ideal for applicants who are required to complete a placement as part of a Work Integrated Learning (WIL) subject at their education institution. Professional placements are open for both university and vocational education students.

Applications can only be considered if:

- Applicants enrolled in a TAFE style certification course (through a TAFE institution or secondary school) must be at least 15 years of age;
- Applicants enrolled in a registered tertiary course must be at least 17 years of age,
- Are currently enrolled in a registered tertiary or TAFE style certification course,
- The industry placement is a compulsory requirement of their course, and
- The placement is authorised by their educational institution, and they provide insurance cover whilst the applicant is on placement.
- Are based in either Sydney or Melbourne.

2. Internship

For anyone interested in gaining experience in Marketing and Production

An internship is ideal for tertiary students, recent graduates or early-career creatives who wish to gain direct experience of a live entertainment company. Internships are offered in MCG's Marketing and Production departments.

Applications can only be considered if:

- Applicants are at least 18 years of age, and
- Are based in either Sydney or Melbourne.

3. Work Experience

For high school/tertiary students interested in working in the Live Performance Industry

Work experience is ideal for senior secondary school students, tertiary students, recent graduates or early-career creatives who wish to gain direct experience on a professional production. Successful applicants will shadow production crew to develop their understanding of the inner workings of a live production.

Applications can only be considered if:

- Applicants are at least 15 years of age;
- Are based in Sydney or Melbourne, and
- Are able to travel to the performance venue.
- If applicable, applicants are covered by their educational institution's insurance policy.
